

## NIAGARA COUNTY FEDERATION MINUTES APRIL 2005

**Pledge to tile Flag:** Niagara County Federation of Conservation Clubs April 2005 Meeting held on the 25<sup>th</sup>. Called to order at 7:00 **p.m.** by President John Butcher at the 4-H Bldg., Lockport, New York with the Pledge to the flag.

**Minutes:** Motion made from the floor by Chris Schotz to accept minutes as corrected, 2nd by Dave Jacobs. The correction was the insert for the Pheasants Forever Youth Mentor Hunt on September 17, 2005 was omitted.

**Roll Call of Clubs and Directors:** Sheets were passed around and signed by the delegates.

Financial Report: Motion to accept the financial report presented by Gordon Botting Sr. was made by Mark Richardson and seconded by 2nd by Jerry Bennet, carried.

### Spring Shoot at North Forest:

Bryan Meahl: Figures are not in for the Fundraising Shoot. We had 100 shooters. The Beretta Victory representatives were well received and the shooters were pleased to see and use the new 2005 shotguns they had there. These guns ranged in price from a thousand to several thousand dollars. This was a unique experience for all. Despite the rain we through more than 10,000 targets and more than 40% of the shooters had a new experience in one or more of the disciplines. The food was good and the fellowship was great In Brian's opinion the event was a success because many people inquired if there was a chance we could do this again in the summer.

The success of the Fundraising shoot was due to the support we got from North Forest and Brian Meahl. A rough guess on the financials is we made \$1000. We are going to have a wrap up meeting to seek ways of improving the next fund shoot.

#### **Big Game: Dale Dunkleberger**

The NYS Departments of Environmental Conservation (DEC), Agriculture and Markets (DAM), and Health (DOH), together with the United States Department of Agriculture's Animal and Plant Health Inspection Service (USDA-APHIS) are cooperating to develop a comprehensive statewide response to the threat of CWD. Currently there is no evidence that CWD poses a risk for humans or domestic animals. However, CWD poses a significant threat to the deer and elk of North America and, if unchecked, could dramatically alter the future management of wild deer and elk. **NYS Conservation Council:** Gerry Bennett

Gerry read a letter from Ken Zolnowski (NYSCC – R9) to respond to the resolution of Chautauqua County to ban the use of Spinning-winged decoys (SWD's)

Gerry reported last Monday he went to Albany to and talked with Wally Johns Legislative Vice President of the NYSCC and nine legislators on A1815/A1536/S2742 which provides for the issuance of junior big game licenses to persons between the age of 14 and 20. Also, they talked about A1990/S698 crossbow Legalization.

In response to several questions about the NYSCC position on many bills, Dale Dunkleberger explained the NYSCC is not telling us how to vote on these bills. A lot of resolutions from the NYS Federation of Conservation Clubs were submitted to the council several years ago and are just coming out in a bill. Many bills go to a committee and die there. After the first of the year the bill has to be resubmitted under another bill number and goes through the whole process again. For instance the crossbow bill has been passed as a resolution by the majority of clubs in the Federation. It has gone back to a committee and been changed many times and has never made it out of an Assembly Committee onto the floor.

Don Jacobs reminded everyone; some bills are put in by an Assemblyman or Senator and bypass the NYSCC. The NYSCC is taking a position on these bills without consulting us. Many times he is opposed to these bills.

Gerry and Dale Dunkleberger are going to Herkimer Friday for a committee meeting.

### **S.C.O.P.E. Bill Mudge**

Bill thanked Dale Dunkleberger and Dave Jacobs for explaining how bills bypass the NYSCC. Bill passed around a copy of SCOPE's 2005 Legislative Report for this week. There are more than 121 bills we are reviewing. The highlighted bills need to be watched or are on the move. New information is in red. If a bill comes out of a committee we oppose and goes to the floor we send out alerts to members. If an alert comes out, I will forward it to President John Butcher and anyone that gives me their email address.

Mark Richardson mentioned the NRA cross-certifies instructors. For a small fee of about \$10 they will upgrade your 4-H Rifle to NRA Rifle.

#### **Pheasant Program - Greg Tessman**

Greg reminded everyone to buy a habitat stamp and then watch where the money is being spent. Remember only the sportsmen are buying the stamp, so the money should go only to sportsmen oriented habitat not into preservation projects.

Greg reported they had their meeting tonight and that is why he was late. They are going to be doing things different this year. There are about 2000 birds. The feed is being paid for by the Safari Club. They are going to have a display at the Fair this year. The field walk will be Tuesday August 9. We would like Federation kids to come out on the lot with the 4-H kids. The habitat sights for Pheasants Forever will be the release sites for the kids. Last year we lost 17% of the birds.
